1. Introduction

Our company provides patient capital, in the form of debt and/or equity, and specialist advice to support a portfolio of high-potential investees. We work closely with investees as collaborative, yet challenging, partners.

AgDevCo has regional offices and country presence in West (Accra), East (Nairobi) and Southern Africa (Cape Town) as well as a head office in London.

2. Role

We are seeking an Agriculture Advisor (AA) to join our Commercial Agricultural team. The AA role will support the company as a specialist ag -investor with a focus on climate impact and resilience, carbon and greenhouse gas reporting, regen agriculture and animal welfare. The person will work closely with senior agricultural advisors and the ESG team in managing pipeline and portfolio processes and project-based investment support in sub-Saharan Africa.

3. Specific responsibilities

Directly reporting to the Commercial Agriculture Director, the AA will:

- Assist investment teams with specific climate risk assessments and mitigation
- > Assist ESG/Ag team with the greenhouse gas accounting assessments of each investment
- Assist in checking of compliance of investments with AgDevCo's Crop Protection Policy, Animal Welfare and Antimicrobial Management and/or farm facing policies
- Develop a knowledge of GIS skills for practical monitoring use in the pipeline and portfolio (NDVI, remote sensing information)
- Provide support to Senior Agricultural Advisors, assisting on existing and prospective investments:
 - Develop agronomy and business review advice (internal and external)
 - Suitability checks in relation to location specific operating climate, soils, altitude and water availability



- Benchmark target field management, crop yields and livestock production targets, equipment, irrigation requirements with other projects including labour requirements and benchmark efficiencies
- Gross margin models for use in due diligences and business plan preparation
- Maintain templates for ag-team's field use
- Maintain active list of technical ag-consultants and assist with preparation of Terms of Reference and Contract preparation for external consultants
- Assist in the review technical assessments prepared by ag-team members and/or external consultants, including but not limited to:
 - Due diligence reports,
 - Technical business reviews, and
 - Technical sector and market reviews.
- To assist in specific projects with investments and/or for AgDevCo, like Ag-weeks, technical assistance to investees or other internal training events.

4. Profile

Interested candidates that meet the following requirements should consider applying.

- Minimum of a Bachelor of Science degree in general agriculture or related subject
- Proven experience in operational agricultural business role
- Project management skills is a plus
- Understanding production costs and gross margins
- Passion for agricultural development
- Analytical, entrepreneurial, and communicative
- Computer literate, able to work with MS Office programs and preferably with Climate tools/GIS/farm management programs
- Resident in Africa and willing to travel 25-30% of the year to visit AgDevCo projects
- Fluency in English, verbal and written, with excellent reporting, presentation, communications and interpersonal skills. Strong applicants will have demonstrated experience delivering presentations to senior-level staff or stakeholders.
- An ability to work independently, as well as part of a team. We are looking for individuals with the humility, patience and good humour required to make strong team players. The individual should be able to manage expectations and deadlines.
