Notice of Special Interest (NOSI)

NOT-OD-24-119 Research Opportunities Centering the Health of Women Across the HIV Research Continuum. The NIH Office of Research on Women’s Health ([ORWH](#)) in partnership with other Institutes and Centers, are issuing this Notice to highlight interest in receiving HIV research and training grant applications that explicitly and intersectionally center the health needs of cisgender women and girls, and gender-diverse people. Despite tremendous scientific advances that have translated to substantial progress in confronting the HIV epidemic, women – and particularly women of color, young women and girls, and transgender women – and gender-diverse individuals remain disproportionately affected by HIV. An intersectional, equity-informed, data-driven approach is essential to advance HIV research and clinical care for all women with or impacted by HIV across their lifespan and to end the HIV pandemic. Institute and Center-specific areas of high interest for this NOSI are listed in the NOSI. Applicants are strongly encouraged to discuss proposed submissions for this initiative with the scientific contact for the proposed Institute or Center prior to submission to ensure alignment with Institute or Center mission areas and priorities for this initiative. Applicants must select the IC and associated NOFO to use for submission of an application in response to this NOSI. Applications must be aligned with one of the mission areas of the selected IC. The selection must align with the IC requirements listed to be considered responsive to that NOFO. This NOSI applies to due dates on or after June 20, 2024, and subsequent receipt dates through January 7, 2026.
